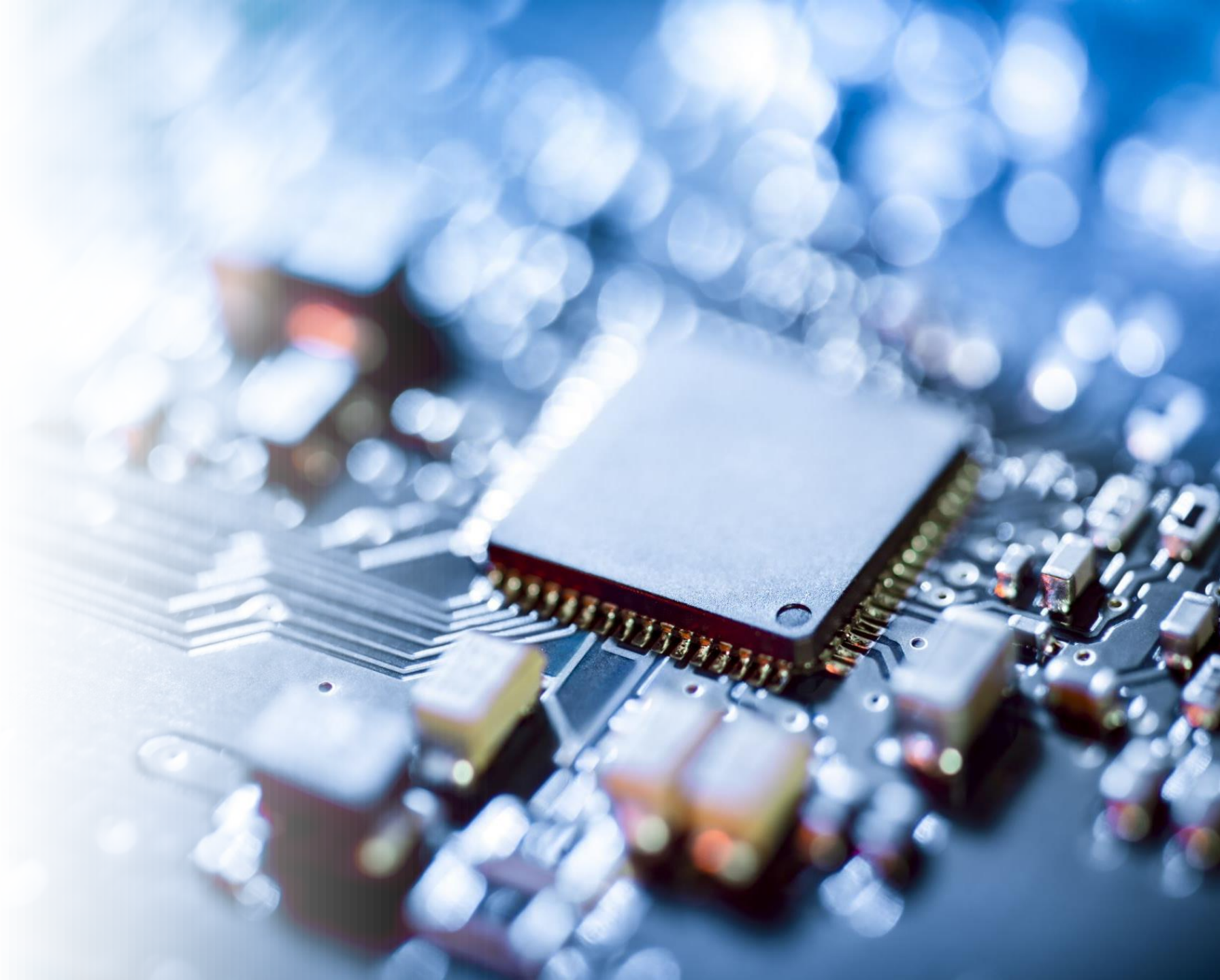

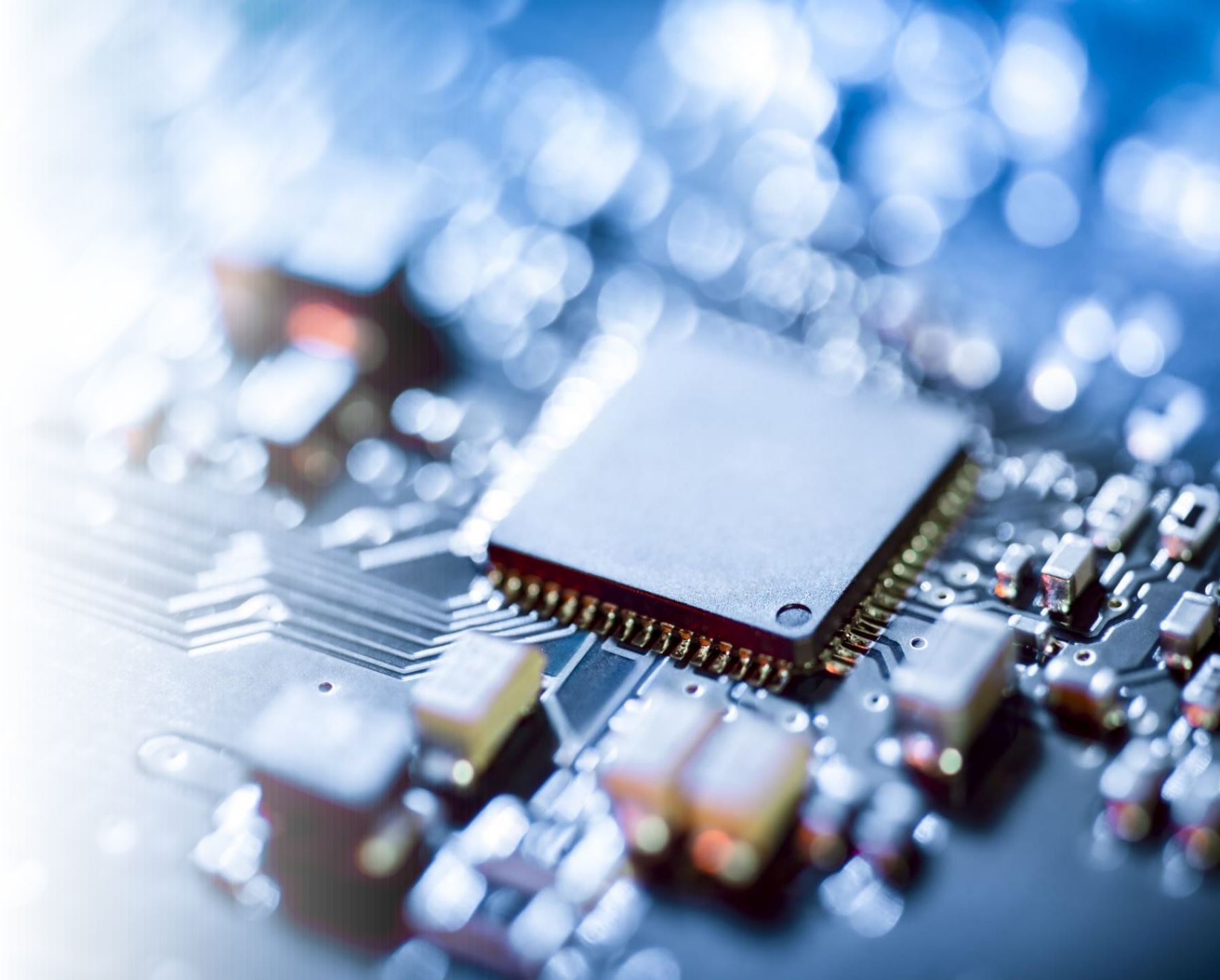



Summary

Objectives

The project develops and implements a complex methodological approach to the education of climate justice and environmental awareness. The activities carried out in international mobilities are the basis for the development of a set of lesson plans and a digital game based on the STEAM approach. It makes a lasting, knowledge- and experience-based understanding, as well as values and attitudes in favour of thoughtful climate actions both at the individual and social level.

Activities

Each partner from Latvia, Spain and Portugal develops 4 complex activities on environmental education, including STEAM elements. The main topics are clean air, water, land, biodiversity, pollution, urban infrastructure, risk mitigation, reforestation, recycling.

Prepared activities during each international mobility are put into practice.

On this basis, an e-book that consists of 12 lesson plans and a digital game are developed covering all activities of the project.

Impact

The project will make a real contribution to the science-oriented approach towards environmental education. It affects environmental values that play an important role in promoting debate on climate change both inside and outside the school environment. Seeing environmental issues through a STEAM perspective allows one to focus on action competence, define a personal position, accept and meet challenges as well as act and work proactively with self-confidence.

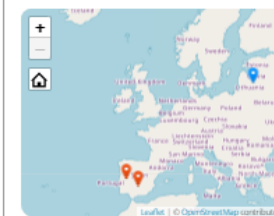


